Spatial concepts


Those that have impacted spatial planning and governance at national and regional level (since the ESDP)

Of national planning in terms of coordinating other policy areas




THE DANISH SPATIAL PLANNING SYSTEM

EU Compendium of Spatial Planning Systems and Policies


- Danish spatial planning as a comprehensive-integrated system
- "... systematic and formal hierarchy of plans from national to local level, which coordinate public sector activity across different sectors but focus more specifically on spatial co-ordination than economic development" (CEC, 1997, pp. 36-37)

HISTORICAL BACKGROUND 1ST MUNICIPAL REFORM (1970)



Executed based on:

Territorial considerations

Synchronised effort to address inequality / demographic unbalances

Functional relationships

Mobility & commuting patterns between municipalities

Logic: One city – one municipality

State spatial project to attain:

Territorial synchrony

To differentiate state territoriality
To provide functional unity and
Operational coordination and coherence


1ST MUNICIPAL REFORM & THE DANISH PLANNING SYSTEM

1970s - 2007

National Planning

Overall framework established through guidelines and directives





Regional plans
Revised and
published every 4

years

Municipal plans

Revised and published every 4 years

Keynesian welfare national state

Planning as "...the spatial expression of the welfare state"

Planning as a societal need to achieve equal development!!




Principle of framework control

Plans at lower levels cannot contradict plans at higher levels

NATIONAL AND REGIONAL SPATIAL PLANNING



2ND MUNICIPAL REFORM (2007)

- Amalgamation of municipalities and abolition of the county level
- Process geared towards managerial efficiency and economies of scale, overlooking geographical criteria
- Rescaling of planning tasks and responsibilities:

"Centralised – decentralisation"




- The scope and performance of the planning system changed in terms of:

 - → Institutional arrangements



THE NEW DANISH PLANNING SYSTEM









- Hybrid spatial concepts




- New spatial logic

2010 National Planning Report



- In 2012 'Green focus': Sustainable growth, climate and energy, 'the open land'...
- Unrelated with the differentiated, strategic spatial reasoning and framing of the former generation of plans (1992, 1997, 2000, 2003 & 2006)


State's interests in municipal planning



- Instrument stating national (sectoral) policy interests and considerations
- The Minister has the right and obligation to veto municipal planning proposals that contradict national interests

REGIONAL 'SPATIAL' DEVELOPMENT PLANNING THE POLICY DIMENSION

- Visionary scope
- Focus on regional strengths for economic growth
- In accordance with business development strategies



REGIONAL 'SPATIAL' DEVELOPMENT PLANNING THE GOVERNANCE DIMENSION

Administrative Regions – Regional spatial development plans Bottom-up, multi-stakeholder processes; flexible character

Regional Growth Forums – Business development strategies
Partnership-oriented bodies; receive EU structural funds

Municipal contact councils – Informal political initiatives 'Soft' parallel planning arenas to foster inter-municipal collaboration

Contested policy objectives and 'competing' governance arrangements hinder the implementation of RDPs

SUMMARY

From "equal" to "appropriate" development

From welfarism to neoliberalism

From framework control to "centralised decentralisation" Due to the abolition of the county level

Divergence from the comprehensive-integrated tradition

Less to do with spatial coordination

Towards less spatial national and regional (spatial) planning?

Latest policies drift away from (EU) strategic spatial planning

Loss of political clout

Government support of other sectors has indirectly decreased the strategic spatial conception of planning at national and regional levels
